

## **Current Projects**





Cascade is a 900 megawatt (MW) combined cycle natural gas fired generating facility in Yellowhead County. The project will have the capacity to supply over 8% of the province's average electricity demand. The facility will utilize modern, high-efficient industrial turbines, and will commence operations in 2023.

Pipestone is a 32 MW cogeneration facility that provides power and heat to Tidewater Midstream's 100 MMcf/day Pipestone gas plant.



## Our Approach to Sustainability

At Kineticor, sustainability is embedded into the way we do business, our decision-making processes, and everyday activities since our inception in 2013. We enlisted ESG-focused third-party input combined with guidance from both the Global Reporting Initiative ("GRI") Standards and Sustainability Accounting Standards Board ("SASB") Standards to complete and determine our sustainability priorities.

Our strategy has always been driven by a holistic, long-term perspective, one that prioritizes our sustainability objectives and ESG performance. Our ESG approach at Kineticor is managed by our Sustainability Working Committee. This Committee is composed of individuals from across the business to provide a diverse perspective on Kineticor's efforts on ESG topics and to support the activation of our approach to ESG throughout our business.



#### **ENVIRONMENT:**



Kineticor's environmental stewardship strategy is to minimize our environmental impacts through best practices and vigorous environmental management programs, thoughtful vendor selection and eco-friendly product procurement. We are committed to always meet or exceed environmental regulations and industry standards. We strive to be stewards of the environment, carefully managing our impacts on emissions and water management.

#### What it means to us

Kineticor will lead Alberta's electricity transition by generating high efficiency, low-emitting and reliable power generation, supporting the province's transition off coal-fired power and the integration of renewables.

## Our approach

Once complete, the Cascade Power Project is expected to be the largest and most efficient combined cycle power plant in the province, producing approximately 62% less CO<sub>2</sub> equivalent per MWh than existing coal-fired generation, and at least 30% less CO<sub>2</sub> equivalent per MWh than a typical coal-to-gas conversion. With Alberta contributing over 50% of Canada's GHG emissions from electricity generation, the Project is expected to result in one of the largest emissions reduction opportunities in the country's electricity sector.

Kineticor is committed to continuous improvement and will maintain our focus on ways to further reduce our emissions. We recognize that we need to decarbonize our economy and the electricity sector is a very important part of this transition.

## **Advocacy and transparency**

Kineticor will continue to be engaged in stakeholder processes as policies are reviewed and developed. Our team members have been active participants in electricity sector and carbon-focused policy engagements, from Alberta's review of its electricity market system to the creation and reviews of provincial and federal

carbon policies. We will continue to engage with government and regulators at all levels to better understand and support regulatory development and the evolving carbon market.

#### **KEY PERFORMANCE HIGHLIGHTS**

- Establish measurement for emissions baseline Kineticor understands that the first step in emissions reduction is to determine the baseline impact. The Company has established continuous measurement of fuel and electricity consumption at project sites, reported monthly in construction/operations reports.
- Energy efficiency Kineticor is committed to using its energy efficiently, implementing solutions for more efficient energy use to reduce emissions. Energy efficiency reduces our need for energy, which decreases energy costs and our environmental footprint. We look across our business to find energy efficiency opportunities, including reducing energy consumption at our corporate office and our project facilities.
- Operational efficiencies to reduce emissions at project sites include:
  - Use of low carbon concrete for piling and use in foundations laid
  - Transition from gas operated tools and generators to battery/electric
  - Installation of programmable timers to keep lighting to minimum required levels for security through off hours
  - Use of water from on-site water well to reduce emissions from the transportation of water to site

#### COMMITMENT

- Determine a carbon footprint assessment that will evaluate scope 3 emissions at projects under Kineticor site control.
- Resilience action plan for transition risks: Cascade will introduce mitigation measures related to transition risks once an evaluation is completed.

### **ENVIRONMENT:**



#### What it means to us

At Kineticor, we recognize that water is a precious resource that must be used responsibly. We carefully manage our water withdrawals and monitor our wastewater disposal with a focus on conservation when available.

## Our approach

We strive to minimize our water use and seek alternative options to avoid the use of freshwater. At our facilities, we seek to optimize water use from the beginning, starting at the design stage.

At Cascade, minimization of water demand was a key aspect in the plant configuration during development. Air-cooled condensers were selected in the design process instead of water-cooled condensers to conserve water in the region. Additional wastewater treatment was also added to the project to keep our water consumption low so that the plant would be able to run throughout the year using only the water sourced from on-site water wells, reducing the need to truck water to site. Cascade considered multiple options for its water source and focused on on-site water wells to avoid additional impacts associated with the transportation of water to site.

As required by the Alberta Energy Regulator, water withdrawals from the well will be continuously monitored. This also provides us with daily water consumption data for the project.


Water at the Cascade Power Project will be required predominantly for the boiler feedwater to produce steam in the steam cycle. Water will also be required for the firewater system and potable water system.

#### **KEY PERFORMANCE HIGHLIGHTS**

• In 2021, Kineticor has implemented a **water monitoring and evaluation procedure** which is continually tracked and reported monthly.

 Focus on continuous improvement related to water consumption and water source.

#### What it means to us

### Our approach

Kineticor is committed to its leading health and safety procedures, including proper training programs for all staff. The Board of directors of Kineticor meets on a quarterly basis to ensure that all necessary policies, procedures and industry practices that are designed to protect our employees and contractors, as well the members of the public and environment are being adhered to. To identify opportunities to improve health, safety and environment performance, operations at the field level are regularly assessed.

At Kineticor, we believe that if you see questionable safety behavior, you now own that safety behavior and have the obligation to correct that behavior immediately, whether it is refusing work or stopping work immediately, until safety standards are corrected.

#### KEY PERFORMANCE HIGHLIGHTS<sup>1</sup>

 We track safety performance with two key metrics – total recordable incident rate (TRIR) and lost-time incident frequency (LTIF). In 2021, our employee and contractor TRIR was 0.48 and our LTIF was 0 at Cascade.


#### What it means to us

#### **KEY PERFORMANCE HIGHLIGHTS**

- A number of construction contracts for Cascade were awarded to Indigenous companies, including site clearing, security, surveying, geotechnical, geostructural, transportation, fuel supply and environmental contracts.
- Cascade's EPC provider, BPC, is required to ensure Indigenous companies have the opportunity for work. BPC member PCL has a close relationship with Women Building Futures which includes attending interview days for soon-to-be graduates as well as hiring previous graduates of the program.
